### NOTIFICATION

As per the decision of the 1<sup>st</sup> sub-committee meeting held on 11<sup>th</sup> March 2022, the sub-committee has decided to call for research proposals from the registered pharmacists working in academics in the State of Karnataka.

**Introduction:** Karnataka State Pharmacy council (KSPC) was, established in the year 1963 as per the Pharmacy act 1948. KSPC right from its inception started to function and serve the profession of Pharmacy with utmost dedication and sincerity. KSPC pioneered in adopting innovative methods for serving the profession. KSPC in its pursuit to serve and extend the helping hand to practicing pharmacists, set up a Drug Information Centre published many books to educate pharmacists. In addition, a Social Welfare Scheme named as Karnataka Pharmacy Council Registered Pharmacist Welfare Trust (KPCRPT) has been, introduced by the Council with the intent of providing financial stability for nominees of Registered Pharmacist. KSPC has also introduced Scholarship scheme for legal heirs of registered pharmacist in the state of Karnataka, who are pursuing their pharmacy education (D Pharm, B Pharm, Pharm D and M Pharm).

**Objective:** To encourage and financially support quality research from the academicians and/or research students who are pursuing M.Pharm/ PhD / Pharm D / Pharm D(PB) who are Registered Pharmacists in the State of Karnataka.

#### Eligibility and Criteria for selection:

01. The renewal status of Registered Pharmacist must be up to date / current.
02. The Project must be independent proposal submitted to KSPC.
03. The proposal should not be a part of fulfilment of degree.
04. No objection certificate should be, produced from the head of the institution.
05. Institution should be approved by the Pharmacy Council of India (PCI).
06. The preliminary research facilities should be available in the institute.
07. One proposal from one Principal Investigator (PI) will be sanctioned at any point of time within the duration of project.

### Conditions of the Research Grant:

01. Proposals submitted need to be original and plagiarism in any form will not be acceptable.
02. The candidate shall apply for the grant in the specified online application form available on the KSPC website.
03. Proposal for the research grant will be accepted after approval by the scrutinizing committee of KSPC.
04. Regular progress report, utilization report along with original bills should be submitted half yearly to the KSPC.
05. No other grants or sponsorship should be availed for this proposal.
06. KSPC has the discretion to increase the grant on request at any given time if the research work is exemplary.
07. The research work will be, monitored by the expert committee and if it found to be unsatisfactory, KSPC has the authority to recall the grant.
08. KSPC should be, acknowledged in all publication and presentations.
